And with specific reference to your draft scoping report, we wish to comment as follows:

We wish to echo the important aspects as set out in table 9 , Summary of Specialist Findings-
Site alternative G- Page 31 and 32

- 1) Agricultural Potential: The proposed site is an active high agricultural potential site that is already transformed.
- 2) Avifauna: The site fall within agricultural land (Cereal cultivation)
Blue Cranes were observed within close proximity to the site.
The longer powerline associated with this site poses an increased risk of collision to Blue Crane and Denham's Bustard

In the final instance we wish to point out that tis alternative site is situated exactly where our client has a subway underneath the road to ensure safe crossing of livestock from one side to the other.

It is clients submission that **site alternative F** may in fact be the most viable option as it is situated close to the existing 400 kV powerline and National road, making it easily accessible.
