**DEVELOPMENT OF TWO LOOP IN LOOP OUT POWER LINES FROM BURNSTONE POWER LINE TO PROPOSED SIYATHEMBA SWITCHING STATION**

Sasol Pipeline Operations is affected by your proposed work.

**NO WAYLEAVE WILL BE ISSUED SEPERATELY FROM THE APPROVED DRILL PLAN**

Please take note that the following steps need to be followed in order to issue the Sasol Satellite Operations Conditions and Wayleave.

1. **Contact Sasol Satellite Operations wayleave office via telephone to set up a kick off meeting or a pre-signature meeting 3 days prior to commencement of work.**
2. Sasol Satellite Operations will then indicate the gas pipeline and issue conditions to be complied with prior to issuing the Official Wayleave.
3. At the second meeting Sasol Satellite Operations will then issue the Official Wayleave if all the conditions are met.

If any work starts on or close to our gas pipeline without the official wayleave, **LEGAL ACTIONS** will be taken against the perpetrators.

4. Sasol Satellite Operation would appreciate it if all contractors pertaining to the planned site is at the pre-signature meeting.

Damage to the pipeline may result in the following:

1. Fatality, even multiple fatalities
2. Loss of livestock and environmental impact
3. Damage to property
4. Cost of loss of Production or financial loss could be as high as 1 Billion Rand
